**The Invitation to Bid opening has been extended to October 3, 2023, 4:00PM EST**

**The following information is being provided in response to questions received for this BID:**

Q.1) Where will the training be located?

**a) Hazard Community & Technical College, 1 Community College Dr. Hazard KY 41701.**

Q.2) My government team is telling me that because we have you under the Sourcewell contract we would not have to pursue the bid because it's already been done. I just need to send the pricing. quote, are you in agreement with this?

**a) Per Kentucky Law, to be considered for award for invitations to bid, any supplier wishing to compete would need to complete the bid package and submit per the instructions included in the bid. It is common for bidders to complete the bid package and reference another contract.**

Q.3) Wanted to make sure I was reading the bid correctly with regard to warranty. Am I correct that it must include 7 years of warranty?

**a) Per section 11, Form of Proposal, installation warranty is to be no less than five years and equipment warranty no less than seven years.**

Q.4) Would KCTCS be willing to extend the bid submission deadline, perhaps another week to October 5<sup>th</sup>?

**a) Bid opening is being extended to Tuesday October 3rd, 2023, 4:00 PM EST**

Q.5) Will KCTCS agree to accept the bid via email in lieu of a hard copy?

**a) Per section 2.2.3 Suppliers can complete this bid document and upload it, along with any other pertinent documents to Bid Locker through a web browser. Click on the following link and then click on the Invitation to Bid #KCT-01394. <https://bidlocker.us/a/kctcs/BidLocker>**

Q.6) Upon review, if there are bid terms and conditions Vendor may not be able to agree to, will KCTCS allow Vender to include clarifications or exceptions as part of its bid submission?

**a) Per section 7.1 Responses submitted that include any additional Supplier terms or conditions or contain terms and conditions in conflict with the bid and KCTCS terms and conditions may be deemed non-responsive. Suppliers must refrain from imposing conditions that would modify the terms and conditions of the solicitation or limit the Supplier's liability to KCTCS on the contract awarded on the basis of such Invitation.**

Q.7) Specifically, if there are insurance requirements that Vendor may not be able to agree to will KCTCS consider exceptions to insurance terms and conditions.

**a) Cannot answer this question without knowing what the exceptions are.**

Q.8) Does KCTCS consider electronic signatures to be valid “original” signatures (i.e.: DocuSign)

**a) Yes**
