- 3) What is the average number of KCTCS staff present during working hours?
 - a) The average number of employees (faculty and staff) on the Main Campus during working hours is 151.
- 4) Is any historical F&B revenue/reporting available for reference?a) No.
- 5) Page 5, Item N mentions vending. Is that in the scope?
 - a) No. The vending machines in the Campus Center are managed by another vendor via a separate contract.
- 6) When will college confirm what new equipment will be purchased and in-house?
 - a) Final decisions and purchases will be made prior to August 18. The goal is to have the area fully functional by that date.
- 7) Is there a timeline of remodel expected to accompany the purchase of new equipment, i.e. electrical, plumbing, install, etc.?
 - a) The goal is to have the space fully operational prior to August 18. Renovation of the kitchen is complete, except for the equipment. The HVAC upgrade for the Campus Center, where the kitchen is located, is expected to be completed in May 2025.
