1. The bid opening date has been extended to **May 27, 2026 at 4:00 PM EST**. This extension does not modify or alter the required delivery dates. The successful bidder is still expected to make every effort to deliver the airplane by June 15, 2026, with a firm required delivery date of no later than July 1, 2026.

**2. The following information is provided in response to questions submitted by potential bidders:**

1. If I don't reply/submit a bid, but I have the exact acft that SCC needs for the aviation program, is it allowed for me to supply this plane to their program if no other bidders qualify with their responses/submittals?

**KCTCS Response:** *Only bid responses will be considered for this solicitation per the following sections:*

- **Per Section 2.1.6 – Failing to Comply with Submission Instructions and Section 2.2.3 – Submitting a Response**, bidders must submit a response in accordance with the solicitation requirements and deadlines to be eligible for evaluation. If a bid or proposal is not submitted, the bidder would not be considered for award.
- **Per Section 1.4 – Overview of the Invitation to Bid Process**, all suppliers are invited to participate by submitting responses, and evaluation and award are based only on those responses received.
- **Per Section 6.1 – Method of Award and Section 6.3 – Selection**, award may only be made to responsive and responsible bidders who have formally participated in the competitive process.

2. I don't have time to get qualified as a vendor and respond to the bid (per the above), so, if the first question is "No", then could there be an opportunity to lease the plane to an established vendor with the school system and have that vendor sublease to the school (post-bid)?

**KCTCS Response:** *Your firm does not need to be registered prior to submitting a bid. Only awarded supplier(s) will be required to register per the following section:*

- **Per Section 3.2 – Authorization to do Business in Kentucky**, the requirement to be registered or authorized applies to the awarded supplier, not as a prerequisite for submitting a bid. Therefore, bidders are not required to be fully registered prior to submitting a response; however, per statute the awarded supplier must register with the Commonwealth of Kentucky Secretary of State prior to doing business.

Additionally, the solicitation does not allow for post-bid arrangements that would circumvent the competitive process. Any supplier seeking consideration for award must submit its own response.

**The deadline to submit additional questions has expired.**

Bidders must acknowledge receipt of this and any addenda either with solicitation or by separate letter or email prior to award of contract. If by separate letter, the following information should be placed in the lower left-hand corner of the envelope:
